This is the deadliest time for COVID-19 in Kentucky. We announced the loss of a state employee, Timothy England, this week. He was just 60

We are currently experiencing an escalation in COVID-19 cases and it is vital that we do our part by wearing a mask, social distancing and avoid public gatherings. We ask those in red zone counties to follow recommendations to reduce the spread. This now includes Franklin County.

Year-end Tasks for Employees

It's that time of year when we like to encourage employees to complete some general housekeeping tasks within KHRIS Employee Self-Service (ESS). Please log into ESS and complete the following:

- Personal Profile
 - Have you moved recently? Please check your home address for necessary updates. If you do make a change, please be sure to let your agency HR office know in case they need to update your taxes.
 - Check your emergency contacts. Do you need to add someone or update an existing contact's phone number?
- Election for Online W-2
 - Are you still receiving a paper W-2 a couple of weeks after your co-workers receive theirs electronically? If you are, this is the time to elect an online W-2. It's secure and faster than waiting for the paper version and remains available for you to access at any time.
