Active Employee Currently Enrolled

Go to openenrollment.ky.gov to enroll via KHRIS Employee Self Service (ESS). Please refer to your personalized Open Enrollment letter sent to your home.

Active Employee Currently NOT Enrolled

If you are an active employee, but not currently enrolled in KEHP, you must complete a paper application. Go to kehp.ky.gov to access.

Newly Hired Employee

If you were hired on or after Sept. 1 - Nov. 1, 2015, you are considered a newly hired employee, and must elect coverage for Plan Year 2015 **and** Plan Year 2016. You can enroll using a paper application or use KHRIS ESS. If you use KHIRS ESS see your IC or HRG for the process. If you want to use a paper application, go to kehp.ky.gov to access the form. If you are newly hired after the above dates, you should enroll using KHRIS ESS.

Adding a Disabled Dependent

If you are adding a disabled dependent, you must complete a paper application. Go to kehp.ky.gov to access.

Cross-Reference Payment Option

If you need to make a change or elect a new cross-reference payment option, both members must complete a paper application for both healthcare and FSA elections. Go to kehp.ky.gov to access these forms.

KTRS and KCTCS

If you are a retiree from the Kentucky Teachers' Retirement System (KTRS) or Kentucky Community and Technical College System (KCTCS), you can enroll online via KHRIS ESS. Please refer to your personalized Open Enrollment letter sent to your home.

KRS

If you are a retiree from the Kentucky Retirement System (KRS), you may enroll online via the KRS START portal. Or you can contact your retirement system for the paper retiree application, rates, contribution amounts, and enrollment information.

LRP and JRP

If you are a retiree from the Legislators' Retirement Plan (LRP) or the Judicial Retirement Plan (JRP), you must enroll using the retiree paper application which was mailed to your home. You must contact your retirement system for questions, rates, and contribution amounts.
