Secretary Bailey called the meeting to order at 2:00 p.m. Ms. Jen Thompson called roll.

Secretary Bailey asked for a motion to accept the January 28, 2025, board minutes as read and approved. The motion was made by Steve Gillespie and seconded by Shawn Boggs. The motion passed unanimously.

Secretary Bailey introduced the agenda item *Kentucky Employees' Health Plan (KEHP) Update.*Commissioner Chamness updated the Board on the following items:

- The Department's move to the 4th floor of the State Office Building is now complete.
- Beginning of 2025 Activities: Open enrollment file review and cleanup is now complete. The
  plan continues to address any process issues that arise now that first day coverage is effective
  for Commonwealth-paid new hires. Tax notice letters have been sent to applicable members
  who redeemed wellness rewards in 2024.
- Procurement:
  - o The Transparency RFP is in the scoring process.

- The Finance Cabinet released the Pharmacy Benefit Manager RFP and hosted a vendor conference for the PBM RFP. Interest is strong with eight PBMs attending the vendor conference. Responses to vendor questions will be published later this week. This RFP is scheduled to close on 3/17, though we anticipate that date may be pushed back to a later date.
- o The FSA/HRA/COBRA RFP drafting process is underway.
- On 2024 Performance Guarantees, both Anthem and HealthEquity have narrowly missed one PG each. The calculations and payment of the penalties are being finalized.

Will Adams, KEHP Plan attorney, presented the Board with a summary of legislative activity to date which might impact the plan, including a review of the status of several bills, including HB 423, HB 182, SB 155, SB 12, HB 413, HB 425, SB 74, and HB 401.
