- Procurement Update: Negotiations with medical third-party administrator are largely complete, and the Finance Cabinet now has a draft agreement that is being reviewed and edited. While we do not have a finalized contract, we are moving ahead with preparing all open enrollment materials, including the Benefits Selection Guide.
- The DEI obtained several responses from CVS on the compliance issues surrounding SB 188 /
 190 and we are working on the renewal agreement and open enrollment materials that will memorialize and communicate those changes.
- Final Wellness Fair for 2024 is tomorrow July 31, at the 300 Building in Frankfort. Any state employee who has not yet participated in a wellness fair may attend and an hour for doing so,
