**Executive Order**  
**Office of County Judge/Executive**  
**Ohio County, Kentucky**

A petition having been filed on October 27, 2016 in the Ohio County Clerk's Office, pursuant to KRS 242.020, requesting that a local option election be held in the city of Hartford; and the Ohio County Judge Executive having verified that the petition contains a number of constitutionally qualified voters of Hartford equal to twenty-five percent (25%) of the votes cast in the city of Hartford in the last preceding general election;

Further, pursuant to KRS 242.030(2) and (3), in determining a statutorily appropriate date for a local option election, it is hereby ordered that said local option election be held in the city of Hartford, Kentucky on Tuesday, January 24, 2017.

The conduct of the election will be governed by all applicable statutes, rules, and regulations.

The referendum on the election ballot will ask, "Are you in favor of the sale of alcoholic beverages in Hartford, Kentucky?"
