office by Drew Rogers, 4956 Smiths Grove Scottsville Road, Smiths
Grove, Kentucky 42171. The Winery license # 114-SFW-143

WHEREAS, Warren County Clerk, Lynette Yates, advised that Mr. Drew Rogers
petition includes a number of Constitutionally qualified voters equal
to 25% of votes cast in that territory in the last preceding General
Election.


WHEREAS, IT IS HEREBY ORDERED that the date set for the Local Option Election
in a Dry Territory for a Precinct that Contains a Small Farm Winery
be set for Tuesday, January 24, 2017 at SMITHS GROVE Precinct
D 101 that votes at Smiths Grove Fire Station, 120 South Main
Street, Smiths Grove, Kentucky 42171.

WHEREAS, The proposition to be voted on shall state, "ARE YOU IN FAVOR OF
THE SALE OF WINE AT THE BLUEGRASS VINEYARD? Yes or No vote."

WHEREAS, Within 5 days after filing this Order, the County Clerk shall give to the
Sheriff a certified copy of the Order. The Sheriff must published
pursuant to KRS 424 and post handbills of the order at 5 conspicuous
places in the precinct for two weeks before the election. The Sheriff
shall report in writing to the County Judge Executive that the notices
have been published and posted.
